The candidates having Rank Card of PGCET-2019, K-MAT or any All India Entrance Test rank holders are only eligible to attend.

However, in the case of candidates form Karnataka belonging to **SC/ST and Category I, the aggregate percent of marks of all the years of the Bachelor degree shall not be less than forty five percent i.e. 45% (rounding-off aggregate percent is not permitted).

#### Note:

- 1) Academic eligibility for admission to Full Time MBA. Programme: Course shall be open for candidates who have passed the prescribed qualifying Examinations mentioned above with not less that 50% of the marks in the aggregate of all the semesters / years of the degree examination (cumulative sum of secured marks of all the semesters / years divided by the sum of the maximum marks). However, in the case of candidates from Karnataka belonging to SC/ST and Cat-I, marks shall not be less than 45%.
- 2) Application fee of Rs. 600/- for General Merit and other category candidates, Rs. 300/- for SC/ST/Cat-I only for Karnataka candidates (Production of documentary proof) should be submitted to the Chairperson, Department of Management Studies, VTU, Belgaum in the form of D.D. drawn in favour of "Finance Officer, VTU, Belgaum" payable at Belgaum. Along with Original documents.
- All candidates with PGCET-2019 ranking are required to report to the concerned MBA department time 9 am on 9<sup>th</sup> October 2019.
- 4) All the admissions will be done in concurrence with KEA, VTU and other norms as applicable.
